5/9/13 To receive a brief report from Ward Councillor P Morgan

Cllr Patricia Morgan reported that Balfour Beatty are now Herefordshire Councils contractor for highways maintenance. Herefordshire Council are reviewing their budget and "the role" of the council. Workshops are taking place and Cllr Morgan will advise more in due course. Adult Social Care, Childrens services and Economic development are

priorities. It was thought that the planning department need a change of attitude to be more proactive and permissive and that they should encourage and facilitate enterprise.

6/9/13 Discussion

a) Neighbourhood Planning

Cllr Hewitt attended a meeting held by Putley parish council on 28th August. Both parish councils have decided not to do a neighbourhood plan at present.

b) Strategic Housing Land Availability Assessment

An email from Herefordshire Council outlining the above was previously circulated by the clerk to all councillors, the contents of which were noted.

7/9/13 Highways / Footpaths a) Balfour Beatty

Cllr Hewitt and the clerk had attended the Balfour Beatty launch evening on 10th September. The contracts manager will be Andy Williams. The transition over from the previous contractor seems to have not gone as smoothly as hoped and although training has been given to staff the planned programme of works will not fully commence until October. The company had recently mobilized Wiltshire. They used a lot of jargon but want to communicate and work closely with parish councils as a "trusted partner". £20 million has been put in upfront for the repair of the unclassified and "C" roads, the work on these will start in the spring once winter weather conditions have ceased. There will be local "road gangs" based upon the nine localities. The clerk has sent through details of all the outstanding defects to Balfour Beatty Living Places email address. They wish to be transparent and a system will be in place to trace the progress of defects.

The clerk had received an email about the winter self-help scheme. It was **RESOLVED** that this scheme would not be beneficial to this group of parishes.

b) SID deployments

Balfour Beatty have taken over the SID deployments. All previous dates booked for deployments have been cancelled and they are starting afresh. It was **RESOLVED** to ask for deployments at Little Marcle in December 2013, Knapp Farm in May 2014 and Little Marcle in November 2014. The clerk is to check the costs have not changed before booking.

c) Road conditions

The clerk has reported outstanding defects with Balfour Beatty in September. The A438 is flooding due to a blocked drain Trumpet side of Roots Farm shop. The clerk is to request more 50mph repeater signs for the stretch of road from the Trumpet Crossroads to Pixley Court. The clerk is to chase the implementation date of the speed limit in Ashperton. The clerk is to order 100 sandbags to replenish stocks held. The clerk is to request grit bins for Heywood Lane, Swinmore Lane and Rectory

Change of use of the Coach House in to a holiday park managers residence. Change of use of the Coach House Annex from two number disabled letting rooms for Hopton Arms Public House into a one bedroom holiday let chalet to form part of holiday park.

PC Comment: The parish council support this application subject to it conforming to building regulations

132205/F Pixley End Caravan & Camp Site, Trumpet, Ledbury, HR8 2RA

Proposed change to caravan site to accommodate caravans and tents for twelve months a year rather than from March to October.

PC Comment: The parish council object to this application as it does not specify the particular use of the caravans (static or touring for holiday use) and require a more detailed application with clarification. The parish council also note the current inadequate drainage and site security with a stile and dog access being located within the boundary fence. The parish council are surprised an extension is required based

Cllrs Swaithes, Hewitt, Skittery, Clothier & Clerk upon the sites current usage.
