5. To receive a brief report from Ward Councillor J Lester

Cllr Lester had sent his apologies and emailed through the following report "the cabinet has agreed to put forward a budget of 1.9% plus an extra 2% to be ring fenced for adult social care. As has been noted the broadband contract to provide fastershire for the rest

of the county has been awarded to Gigaclear. I trust that the rest of the coverage required will be delivered in a consistent and joined up way. I organized an event last week to celebrate the work done so far to deliver the County's Children and Young Peoples plan. This comes at a time when it is acknowledged that children's health standard fall well below our European neighbours. The next full council meeting is this Friday, the main business of the day is the budget".

6. Public Participation Session

The owners of The Coach House Munsley are pursuing information from previous owners. Herefordshire Council and Balfour Beatty have viewed the drains and advised that an agreement must have been made with a previous owner of the property and suggested the current owner divert the water to outside their boundary. The clerk has asked the cabinet member for highways to explore this.

9. Highways and Footpaths

9.1 To Discuss Lengthsman and P3 scheme

The clerk and chairman have tried to contact the current lengthsman by phone and visiting his house without success. Therefore an alternative lengthsman has viewed the issues needing work and provided a quote. This quote was discussed and it was agreed to appoint this new lengthsman immediately.

The clerk is to order P3 gates and materials for various areas along the Herefordshire Trail which have been identified by the footpath officers, the chairman confirmed that the landowners have been involved and made aware of their responsibilities. **RESOLVED**

9.2 To Raise any new Highway and Footpath Defects

A grit bin on C1303 and a stile on footpath AL8 have been damaged by a vehicle losing control in icy conditions. This has been reported to the Locality Steward who is arranging replacements.

There is a very wet area on footpath LM8 behind Little Marcle Court that needs remedying, it was suggested that an amount of stone/hardcore be put down. A couple of steps need cutting into the bank where footpath LM4 crosses the A4172 by Newbridge Farm Park. The clerk will ask the lengthsman to view the jobs and advise.

The clerk will report potholes needing repair on A4172 and U67406. Verge markers need replacing by Munsley WI Hall. The hedge along the A438 by Alexander Park needs trimming back. Brambles over the phonebox by Falcon Lane need removing. Weeds are breaking up the tarmac by the Trumpet bus stop. The clerk will report these defects. **RESOLVED**
