5/7/15 Brief report from Ward Councillor Jonathan Lester

Cllr Lester advised that since his last report given at our May meeting the full AGM of Herefordshire Council had taken place. Tony Johnson was elected leader, the cabinet remains largely the same as prior to the election with one change - Cllr Lester is now the cabinet member for Childrens wellbeing - a baptism of fire with the respite centre in Ledbury Road facing closure and

school transport changes. In the Three Crosses ward both Ashperton and Stoke Lacy are facing large housing development planning applications. Herefordshire Council are now putting together their budget for the next four years. They face the challenge of the grant from central government reducing from £30million to zero by 2020. Herefordhire Council are having to budget for further savings of £46million over the next four years. Residents will be consulted on where they want these savings to be made. Cllr Lester will forward the cabinet report to the clerk.

The chairman welcomed Mr Beaumont to the meeting. Mr Beaumont explained that Contact the Elderly is 50 years old this year, there are around 500 groups nationwide, and he is setting up a group in the Ledbury area to take elderly people aged 75 and over out for tea once a month. Volunteer drivers pick up these people and take to the hosting venue, where they have a chat with friends over tea. Lots of new friendships are made, stories told and gratitude expressed. Contact the Elderly helps people have a social life and make new friends. Mr Beaumont gave out leaflets and contact details which will be added to the website.

The parish council gets money from the precept. There are 4 properties in Pixley, 4 in Aylton, 2 in Munsley and 4 in Little Marcl that are banded A properties which include caravans. There are 22 business rate hereditabuts in Pixley, 6 in Aylton, 10 in Munsley and 4 in Little Marcle. Sites rated as agricultural worker accommodation are 83 mobile homes on 2 sites. Of business rates half goes to central government. None or very little caravan revenue goes into parish precepts.

Proposed workshop building and full time residential mobile home

An amended scheme to lower the workshop has been submitted. This application is still waiting a decision

150765 – Trumpet Fields adjacent A438,Trumpet, Ledbury, HR8 2RA Erection of polytunnels on fields at Trumpet for covered commercial growing of soft fruit and new pond area.

- The tunnels that were erected have now been taken down so there is no planning enforcement at present re flood risk. Haygrove are willing to alter the access onto the A438. This application is still waiting a decision.

b) Road Conditions / Flooding / Traffic Management

There is a cone marking an open drain at the Trumpet Crossroads that needs the cover replacing. Some of the drains by Newbridge on the A4172 are blocked. The resurfacing of the A4172 has helped, the new tarmac at Pixley being quieter than the tar and chippings at Little Marcle. Ward Cllr Lester will enquire why this "noisy" surface was used beside Little Marcle residences. Ward Cllr Lester advised that he has supported a speed review on the A4172. Ray Wallace of Balfour Beatty is looking into matters raised by members of the public. Councillors advised that the grass verge cutting in mid-July was carried out too late the seasons growth required a cut much earlier. The clerk was asked to chase up the cutting of Alexander Parks roadside hedge.
